PREAMBLE

The Spiritually Motivated Social Engagement Committee of Centers for Spiritual Living offers this voting guide for the first time as support for voters from our spiritual communities in applying our vision and values when making electoral choices. Centers for Spiritual Living, a nonprofit religious organization headquartered in the United States, does not endorse any candidates for public office. Instead, we encourage our spiritual community to apply Science of Mind teaching, vision, and values in making choices.

We do encourage everyone eligible to vote to register and to vote prayerfully, considering each candidate, ballot initiative, and policy in the light of our vision and values when selecting those who will serve in public office. Although references throughout this guide are made to nonprofit regulations and voting resources in the United States, the spiritual guide to voting may be applied to voting worldwide by adjusting content and nonprofit regulations to local laws and resources.

What is in this guide:

- Voting Our Vision & Values: Quick reference to CSL values and vision to consult when you complete your ballot, whether at home or a polling station.
- Vision and Values One Pager: Centers for Spiritual Living Values and Vision, as stated in our Organizational Design Model (appendices A and B and a printable one-page reference).
- **Engagement**: Quick and easy action steps to increase voter engagement and turnout in your community and to educate and inspire.
- Legal: Reminders on what 501c3 organizations in the United States can and cannot do.

Voting Our Vision & Values

Centers for Spiritual Living Values and Vision Summary

Before voting, familiarize yourself with Centers for Spiritual Living's values and vision. A summary of our values and vision are included below for quick and easy reference. For the complete text, see appendices A and B.

Then, in preparation for voting, research candidates and issues (see personalized ballot information in the Additional Resources Guide section.) Next, set time aside to apply the spiritual practice of vision to your process (see tips and guides below). Finally, when ready to make your selection, ask yourself:

- Which of the candidates for this position display values consistent with those of CSL and its vision of a world that works for everyone?
- Does this ballot measure express the values of CSL and its vision of a world that works for everyone?
- Does this ballot measure reflect a positive direction for all in your community?

Before submitting the ballot - review and make sure you are at peace with your decisions. Check with your spiritual intuition, which our founder Dr. Holmes referred to as Divinity within humankind, about which of these candidates resonate most with your spiritual values. Visioning is one spiritual tool that can be used to access your spiritual intuition.

Guidelines for Visioning (from Centers for Spiritual living Department of Education Visioning Class)

- Determine the focus for the Visioning process, for example, "my vote."
- Center in Spirit. Enter the silence to establish your awareness of the Presence within. Anchor this awareness in Infinite Love, which is the overarching purpose for our lives.
- Open to the vision by asking a question or questions. Pause after each question to receive the vision. Choose four or five open-ended questions (see below) and allow for unknown possibilities to be revealed. Write (or draw) your responses after each question or after the process.
 - 1. What is Spirit's Divine Idea for this (the focus of your Visioning)?
 - 2. What does it look like, feel like, etc.?
 - 3. What qualities of Spirit are expressing through this vision?
 - 4. What is my part in this vision?
 - 5. How must I change to allow this vision to unfold?
 - 6. What gifts do I bring to this vision?
 - 7. What must I release to be this vision?
 - 8. What must I embrace to be this vision?
 - 9. What must I allow others to do?
 - 10. What spiritual work must I do to allow the vision to unfold?
 - 11. What must I become to embody the vision...to become the vision...to live the vision?

Visioning Tips

- Stay neutral during Visioning. Avoid judging, analyzing, or editing.
- Allow yourself sufficient, uninterrupted time to do your Visioning.
- Be patient and allow the vision to unfold and come into form in Spirit's time, not yours. Avoid drifting into planning, controlling, or attempting to "make things happen."
- Be alert to "evidence" that the vision is ready to reveal itself. Be prepared to flow with the vision as it manifests.
- Allow the vision to "speak" to you in a variety of ways: a color, a feeling, a sound; a smell; a thought or word(s); a knowing; an image, or nothing at all.

Suggestions for Clergy and Study Group Leaders

Getting out the Vote:

This Engagement Guide is to help you support the spiritual community that you serve to be informed about the vision and values of Centers for Spiritual Living when voting. We offer this guide to clergy, teachers, and study group leaders to help educate, enroll, and inspire individuals in your community. Although not the primary focus of this guide, this work will also help grow awareness of the Science of Mind in the area that you serve.

Educate

Educate your community on important deadlines, such as the deadline for counting the US Census, which has been moved to September 30. It is important that every person be counted.

Weave references to civic issues into your Sunday messages, study group discussions, and classes, noting that encouraging voting is in alignment with Centers for Spiritual Living vision and values. An excellent resource for civic engagement can be found in *The Essential Ernest Holmes*, chapter 9.

Offer classes on citizenship, voting, and local government structures and impact. Your state may have educational content available, like, for example, the <u>Institute for Local Government</u> in California, or <u>The Comprehensive Digital Course on History, Government & Economics</u> by the Bill of Rights Institute.

Enroll

Announce opportunities for volunteers to enroll in civic duties related to voting. Identify a leader or coordinator/liaison who can help research other local groups for possible collaboration. Tasks may include:

- identifying information sources for nonpartisan values-based descriptions of ballot measures and candidate positions
- brainstorming ways to support those who may be voting in person (while adhering to all local health directives)
- gathering & distributing voting and registration information sources in your local county
- gathering information about the registration requirements such as voting online, in person, and identification.

Inspire

Here are some Ernest Holmes quotes that you can use when talking about/posting information about civic responsibilities in a spiritual context:

We must think peace if we wish to express peace. The mind that is always confused and distraught is not at peace; the mind that is continuously upset and agitated by the little, petty things of life is not at peace; it is at war with itself. It is only when the individual mind ceases combating itself that it will stop combating others. We do not know when that far-off Divine Event will transpire which shall heal the world of the wounds of war, the memories of ancient strife and the anticipation of future struggle. All we know, as individuals, is that it is within our power to control our own thinking, to so order our own mind and thought that we, as individuals, shall be surrounded by peace.

Legal Centers for Spiritual Living

Currently, the law prohibits political campaign activity by charities and churches by defining a 501(c)(3) organization as one "which does not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office."

A Church Can:

- Conduct non-partisan voter registration, identification and "get-out-the-vote" drives, encouraging members to vote
- Take positions on, conduct petition drives on, lobby on, and make expenditures on legislation, referendums, or other issues
- Distribute non-partisan voter education information including educating church members on legislative and political matters
- Apply church teachings and values to politics, legislative matters, or candidate positions
- Introduce political candidates and allow them to address the congregation in their capacity as candidates as long as all candidates seeking the same office are given an equal opportunity to participate, and the church does not express support or opposition for any particular candidate(s)
- Host candidate forums where all candidates are invited and allowed to speak
- Support or oppose political appointments (such as judges or cabinet officials)
- Rent church member contact lists to favored lobbying groups
- Pastors may endorse candidates as individuals, but not on behalf of a church, (if title and church name are used, include a "title and affiliation for identification purposes only" disclaimer)

A Church Cannot:

- Endorse or campaign for candidates for elected office in the name of the church
- Contribute money or make "in kind" contributions, (such as resources or services), to a candidate, political party, or political action committee
- Distribute materials that endorse a candidate or political party
- Allow candidates to solicit funds from the congregation (from the pulpit)
- Create a church political committee that would do any of the above

An informal review by our legal committee on 08-28-2020 of this section of the policies and procedures, especially paragraph C.1 below indicated that it needs to be revised to comport with existing law. See also the recommendations above in this guide prepared by the CSL legal committee which clarify that 501(c)(3) organizations may "take positions on, conduct petition drives on, lobby on, and make expenditures on legislation, referendums, or other issues."

1.8. <u>Political Activities Strictly Prohibited</u>

A. Member Communities and members of an affiliated group of Member Communities that are exempt from taxation under section 501(c)(3) of the Internal Revenue Code ("IRC") should refrain from political activities at all times. The Internal Revenue Code provides that one of the criteria for qualification as a tax-exempt organization under IRC §501(c)(3) is that the Organization must "not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of (or in opposition to) any candidate for public office." The prohibition against political activities is applicable to politics at the federal, state and local levels. It is also applicable to political activities in foreign countries.

B. If a Member Community engages in political activities, it may be classified as an "action organization" and may be disqualified for federal tax-exempt status under IRC §501(c)(3). The Member Community may also be disqualified for state tax-exempt status. It is extremely important for Centers for Spiritual Living and its affiliated Member Communities to avoid engaging in activities that could be characterized as political activities. If your Community is considering an activity that involves a political issue, it is essential to seek immediate advice from legal counsel prior to engaging in the activity. The Internal Revenue Service will revoke the tax-exempt status of a Member Community that engages in political campaign activities.

C. Examples of activities that should be avoided by Member Communities include the following:

1. Contacting members of a state, federal or local political body to urge action for or against any legislation, including a proposed or current law, referendum, initiative or constitutional amendment.

2. Making oral or written statements in favor of or in opposition to any candidate for public office (whether local office, state or federal office).

3. Not allowing all candidates for a particular public office the equal opportunity to speak at your community (i.e. extending a speaking invitation to one candidate over another). Rev. Rul. 2007-41, 2007-25, I.R.B. 1421.

4. Placing web links on the Community's website or publications that direct people to websites supporting a political candidate.

In it, they lay out an interfaith values-based approach to voting on matters of Democracy & Voting Rights, Climate Justice, Loving our Immigrant Neighbors, An Economy of Inclusion, Moral Health Policies in a Time of Pandemic, Restorative & Racial Justice, Respecting the Dignity of LGBTQ People, and the Global Common Good. They do not tell us what party or candidate to vote for. They give us a way to lovingly approach these issues that parties and candidates are talking about--we think it would be hard to create a better guide.

OUR SHARED VALUES

SECTION TWO – Organizational Design Model, page 6:

Accountability: We account for our activities, disclose them in a transparent manner, and accept responsibility for our actions and the obligations entrusted to us.

• Open Communication: We communicate openly with each other in an atmosphere of collaboration and inclusion.

Financial Health and Prosperity: We express order and balance in our finances and experience optimal financial well-being. - Community Service: We dedicate our time, talent, treasure, and expertise to the healthy and joyful evolution of our spiritual community, the community in which we live and the greater community of the world.
- Safety: We create a community wide climate conducive to honest reflection and deep and direct communication.
- Compassion and Caring: We express interest in and support for the well-being of ourselves and others. We express unconditional love when observing the suffering of others and do what we can to give aid and show compassion.

Spiritual Living: As we learn and practice our philosophy, the Science of Mind, we live principle-centered, Spirit-led lives and turn to our principles for guidance in all moments and all areas of our lives. We express Spiritual Living as:

• Diversity and Inclusivity: We value, embrace and celebrate the individual uniqueness and contribution of all people as they express through differences of gender, ethnicity, culture, history, experience, talents and sexual orientation. We

include representatives from all our organizational constituencies in leadership, sacred service and decision making.

- Education: We walk a path of awakening, growth, and spiritual deepening through classes, workshops, seminars, and spiritual practices that allow us to embrace education as a lifelong endeavor.
- Transformation and Evolution: We do deep inner personal work of self-discovery and healing to reveal the greater truth of our Divinity, wholeness, and freedom.
- Creativity: We allow the ongoing activity of Spirit into our hearts, minds and activities to bring forth new forms and expressions to inspire and guide.
- Continuous Improvement: We consistently welcome more and more of the Divine Nature to be realized within us and revealed through our relationships, our decisions and our contributions to the world.
